**Code of Conduct**

**General Discipline**

- Students are expected to enter in to the campus in the specified uniform.
- Every student is expected to be in simple and modest formal dress.
- Boys are expected to have a normal Hair cut.
- Wear the identity card within the college campus is mandatory
- All students should follow the class and lab schedule punctually
- The students are expected to keep standing in silence during National Anthem sharp at 11.00 AM.
- Students should remain standing as the teacher enters, and again as she/he leaves the classroom.
